23/24/308 Report from Central Bedfordshire Councillor(s)

Cllr. V. Malone:

There is no further update on the field on Markyate Road. The owners had until end of October to put in a planning application.

Cllr. K. Collins:

Had no updates. The council asked Cllr Collins to speak to Central Bedfordshire Council to inform them that the flooding in Grove Road Slip End is still an issue. There has been no difference after work was carried out to combat this with flooding over the raised kerb into the ditch.

23/24/309 Flooding Working Committee Update

Cllr. Brennan reported that Front Street experienced problems with the drains overflowing during the recent flooding. Cllr. Brennan will report it on Fix My Street.

Cllr. Minnighan has been liaising with Central Beds Council regarding local flooding issues. The drains were looked at by the Aley Green village sign in Woodside and were found to be damaged. This is being addressed. A survey has been started of the drains from Woodside Farm down to the Aley Green junction. This has only been half completed and Cllr. Minnighan is liaising with CBC.

New Storage Container

The storage unit has now been ordered. It will be sited in the Village Hall car park.

Flood Kit

It has been reported that the Hydro sacks take a long time to inflate.

We had two requests from residents for sandbags and hydro sacks and these were supplied. Prefilled Sandbags was explored, and they can be obtained at an approximate cost of £180 for 60 sacks should these be required. We will continue to supply empty sandbags and ask residents to fill them. Another notice will go in the Parish News and on the Parish Council website.

Cllr. Minnighan spoke to Kompan our playground supplier about the bolt that is broken on a piece of equipment in the playground. The quote was received for £42. 85 as the whole bolt unit needs to be replaced and has been ordered. It is not dangerous and will not cause any damage.

23/24/312 Good Neighbour Scheme

26th November is the lights switch on outside the Village Hall with a Christmas Market. If the weather is bad, stall holders will have access to the Village Hall.

226 biscuits have been ordered with Christmas Cards for elderly residents in the parish.

20th December - Christmas Party at the Village Hall.

Soup and Sandwich— has had 120 people attend so far, and it has been successful with new residents each week.

Replacement Defibrillator at the Village Hall has been ordered at a cost of £1296.00. The code to the unit will be changed and updated on the East of England Ambulance List.

Swimming Pool at Slip End Village School – sent a request to the Parish Council for a contribution to their fundraising to refurbish the swimming pool for the school and for local community use. The council are looking at the request and will discuss this at the next meeting on the 4th December. Any contribution will be allocated in the new financial year in April 2024.
